# Features & Benefits

## Vehicle Insurance

This product is suitable for owners of prestige, classic and collectable vehicles that are for private use:

### Features

- + Ability to set an agreed amount for which the vehicle is insured for providing greater certainty (known as Agreed Value)

- + Ability to keep the unrepaired Insured Vehicle for a Total Loss claim (this is known as salvage rights and is only applicable where the vehicle is 25 years old or older. It is not applicable if the vehicle is stolen)
- + We will pay up to \$30 million in legal liability for accidental loss or damage to someone else's property caused by the Insured Vehicle

### Additional Benefits

- + Cover for stolen tools and spare parts, up to the lesser of the combined market value of all spare parts and tools stolen in relation to any one claim and the maximum cover amount You have chosen
- + Cover for stolen or copied keys, locks and barrels, up to \$1,000 per claim
- + No Excess for the first Accidental damage the Insured Vehicle's windscreen, sunroof or window glass during the Period of Insurance
- + Cover for Accessories and Alterations which have not been declared, up to the lesser of a maximum of \$20,000 per claim or the Agreed Value
- + Cover for Defensive Driving Courses (only available under Comprehensive Cover)
